

Letter of Agreement

Between

İstanbul Kültür Sanat Vakfı, Sadi Konuralp Cad. Nejat Eczacıbaşı Binası, No.5
Şişhane, Beyoğlu, 34433 – İstanbul, represented by Görgün Taner, General Director

Istituto Italiano di Cultura Istanbul will support the concerts of Salvatore Bonafede, Luigi Grasso and Stefano Bollani within the frame of XX Istanbul Jazz Festival which will take place between 2-18 July 2013.
İstanbul Kültür Sanat Vakfı has signed a separate contract with all the musicians above mentioned.

The conditions of the support, the services to be provided by IKSŞ and the rights of Istituto Italiano di Cultura Istanbul are set out in this letter:

1. Istituto Italiano di Cultura Istanbul agrees to support the concert of Salvatore Bonafede on July 6, 2013 at 18.00 at the Theater of Casa d'Italia, in Meşrutiyet Cad. 75 Tepebaşı.
2. Istituto Italiano di Cultura Istanbul agrees to support the concert of Luigi Grasso on July 15th, 2013 at 22.30 at Salon IKSŞ.
3. Istituto Italiano di Cultura Istanbul agrees to support the concert of Stefano Bollani on July 15th, 2013 at 21.30 at the garden of Archaeological Museum.

4. Istituto Italiano di Cultura Istanbul's conditions of support and İstanbul Kültür Sanat Vakfı's responsibilities will be as follows:

a . Istituto Italiano di Cultura Istanbul agrees to give a financial support of **7,500 Euro (seven thousand five hundred Euro)**. İstanbul Kültür Sanat Vakfı will be responsible for using this amount to cover all the financial aspects (fee, artists' flights, instrument transport, accommodation, local transportation) and technical aspects related to these concerts including and not limited to the rental of the venue, production, ticket sales, publicity of the performances. Istituto Italiano di Cultura Istanbul agrees to pay for the above mentioned amount on July 16th 2013. İstanbul Kültür Sanat Vakfı agrees to give a receipt to Istituto Italiano di Cultura Istanbul.

4. İstanbul Kültür Sanat Vakfı will be the sole responsible for the sponsorship of the concerts. Istituto Italiano di Cultura Istanbul agrees that İstanbul Kültür Sanat Vakfı can claim support from another company for both concerts.
5. Istituto Italiano di Cultura Istanbul's support will be acknowledged by the use of the logo of the Istituto Italiano di Cultura Istanbul (in accordance with the corporate design standards of the İstanbul Kültür ve Sanat Vakfı) and appropriate wording on the posters, banners, catalogues, brochures, daily programme, press releases and website, on the newspapers throughout the festival period and on signage at the entrance to the performances and on the vinyls to be placed in the concert venue on the day of the concert.
6. IKSŞV agrees to reserve the invitations to Istituto Italiano di Cultura Istanbul as follows:
 - 6 seats + 6 standing invitations for Luigi Grasso performance on July 15th at 22.30 at Salon IKSŞV.
 - 4 invitations for Luigi Grasso with China Moses performance on July 13th at 21.15 at Sabancı Museum.
 - 30 invitations for Salvatore Bonafede performance on July 6th at 18.00 at the Theater of Casa d'Italia.
 - 15 invitations for Stefano Bollani performance on July 15th at 21.30 at the garden of Archeological Museum.
7. Istituto Italiano di Cultura Istanbul will not make any further payments in connection with these concerts and accepts no liability whatsoever.
8. İstanbul Kültür ve Sanat Vakfı is obliged to pay back the grant within 30 days,
 - In the case of cancellation of the concerts due to force majeure (fire, natural catastrophe, any outbreak of disease or infection, including without limitation and for the avoidance of doubt the severe acute respiratory syndrome or any variants or similar syndromes, war, civil war, armed conflict or terrorist attack, nuclear, chemical or biological contamination or sonic boom, industrial dispute, national mourning, failure of national or local power supply or any other circumstance beyond the control of the Artists or of IKSŞV)
 - In the case of circumstances which are caused by İstanbul Kültür Sanat Vakfı
 - if the current contract becomes invalid;
 - if the conditions on which this contract is based are subject to change;
 - if İstanbul Kültür Sanat Vakfı breaches its contractual responsibilities;



- if they do not use the provided material by the Istituto Italiano di Cultura Istanbul exclusively for the concerts described in item 1, 2 and 3.
- if the contract has been signed based on incorrect or incomplete information, in particular if they have provided a calculation that is incorrect, incomplete or is not based on best international practice

9. İKSV agrees to maintain confidentiality during this Agreement and after the termination of this Agreement, no disclosure to any third party of any information arising from this Agreement shall be made (other than in the proper performance of your duties), except with the prior written permission of the Istituto Italiano di Cultura Istanbul for all concerts.
